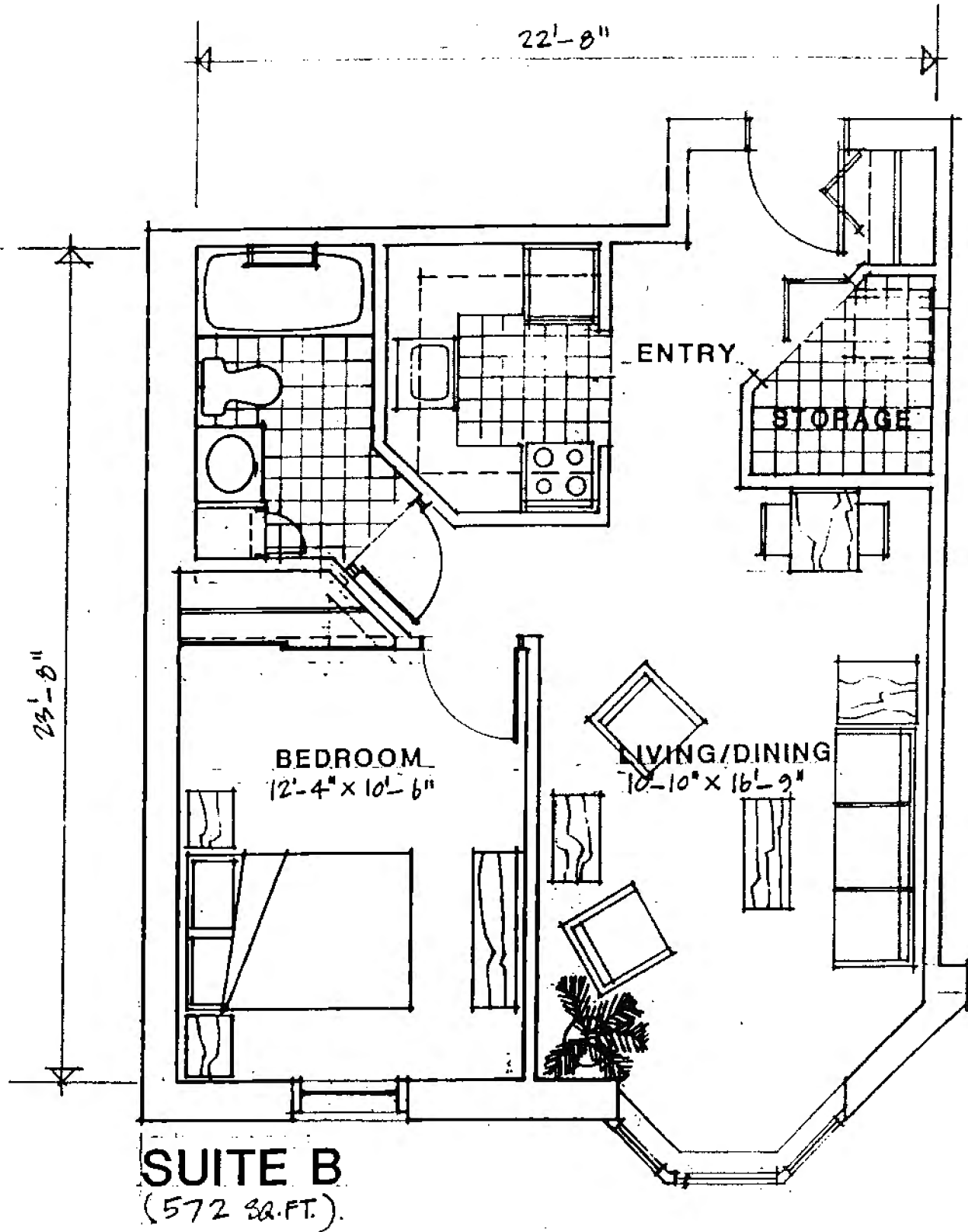

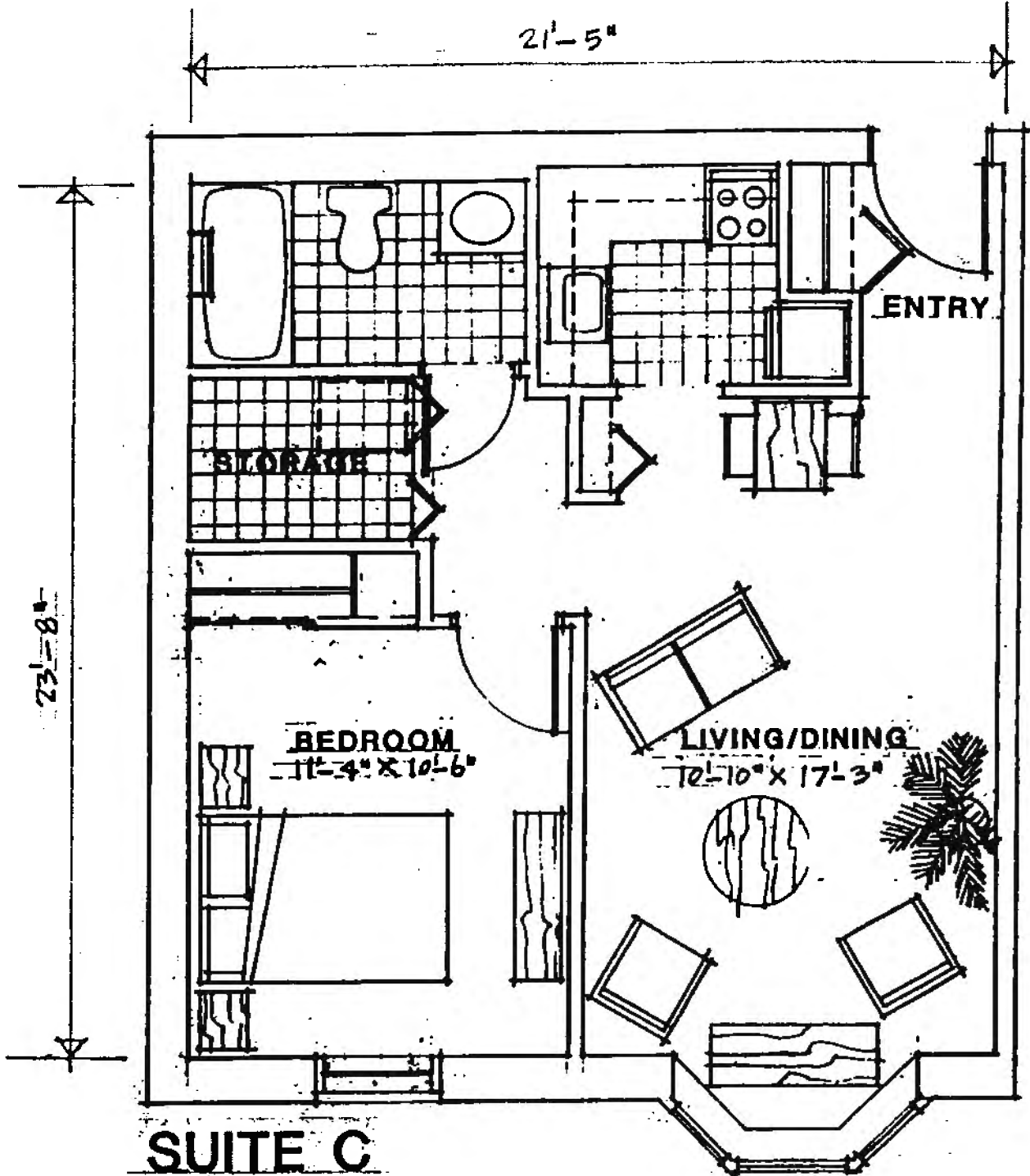

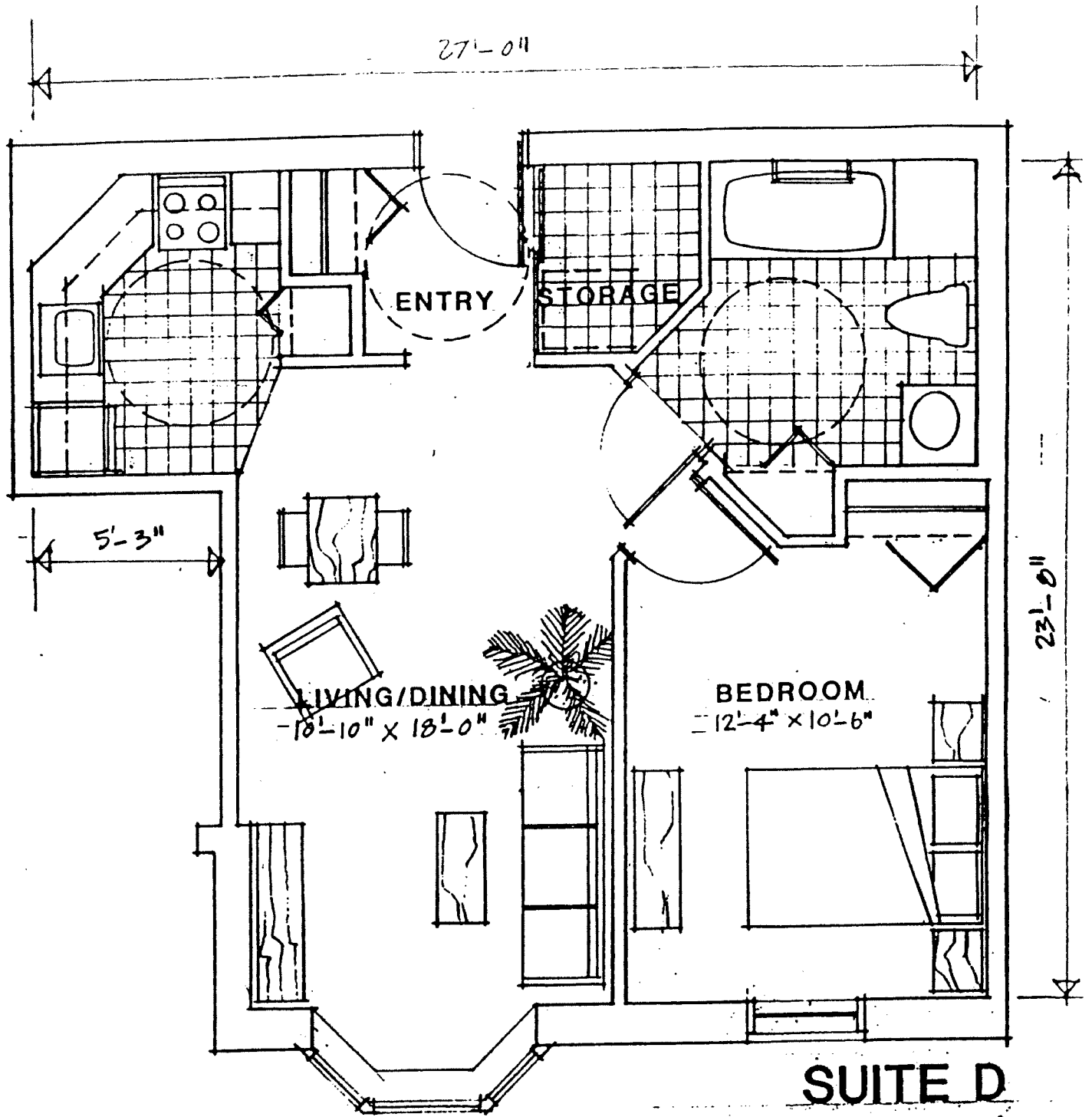
SUITE A
